### COVID-19 Safety Protocols

\*Protocols are based on recommendations made by the CDC, as well as state and federal guidelines for camps as of March 29, 2021. In the event that recommendations or protocols are altered between March 29 and July 27, parents of campers will be notified of changes via email.

- On departure morning (July 27th) campers will need to present one of the following three items:
  - 1. A negative COVID-19 Test within the past 96 hours
  - 2. A positive COVID-19 Antibody Test
  - 3. Proof of COVID-19 Vaccination
- Masks must be worn on the bus ride to and from camp and during indoor services while at camp. Masks are not required at any other times during camp.
- Temperature checks will be done each morning by group leaders.
- Two nurses will be onsite at all times.
- Campers with symptoms of possible COVID-19 or are exposed to someone who tests positive for COVID-19 will be taken to the Nurse's Station and tested as soon as possible.
- If a camper tests positive, the Camper will be kept at the Nurse's Station until they are picked up by a parent or quardian.
  - The remaining campers in the group will then be tested

All campers must attend an orientation meeting with a parent or guardian prior to camp. All meetings will take place during June and July at the West End building located at the Mission Campus. The meeting times will be 15 minutes after each Sunday service as well as Wednesday nights after each youth service in June and July.

The camp is staffed with two nurses and a fully stocked medical station. All medications MUST be turned in to the Nurse's Station the morning of departure and will be returned upon arrival to PVC at the end of the camp session.

Please be sure to adhere to the following guidelines:

All medications (prescription and over-the-counter medications) must be brought to the Nurse's Desk at check-in the morning of departure. Over-the-counter medications must be in their original, unopened packaging and prescription medications must be in their original prescription containers. This rule applies to all medications except for emergency medication allowed by Texas state law: an inhaler or EpiPen. However, written approval is required for any student who will be carrying an emergency medication. Written approval can be obtained from the camp nurse departure morning. You can expedite this process by pre-filling the medication form(s) and bringing a printed copy with you to the Nurse's Desk on departure morning. All medication will be returned at the end of the camp session.

# What not to bring:

- No clothing with vulgar or suggestive slogans
- No water guns or water balloons
- No valuable items such as jewelry or electronics (PVC will not be held responsible for theft, loss or damage of valuables)
- No prank or gag materials
- No firearms, fireworks, tobacco, electronic cigarettes, vapes, drugs, alcohol, knives, or weapons of any kind\*

<sup>\*</sup>Campers bringing these items to camp will be immediately sent home at the cost of the parent.

# Policy/Frequently Asked Questions:

#### **Behavior Policy:**

Students must obey staff instructions at all times. Students are required to stay with their assigned group and leader during group times. Students are not allowed in or near the cabins of the opposite sex. No public display of affection is permitted. Students must remain in their cabins once evening activities have finished. No firearms, fireworks, tobacco, electronic cigarettes, vapes, drugs, or alcohol are permitted at camp. Campers bringing these items into camp will be immediately sent home at the cost of the parent. Foul language, fighting, or bullying will not be tolerated. The leadership of Palm Valley Church Student Ministries will handle any behavior problems. All parents and students must understand the importance of these guidelines and remain committed to keeping them. The consequences for misbehavior may include the student being sent home early from camp, at the parents' expense.

#### **Cell Phone Policy:**

Whether or not your student takes a cell phone is your decision. Cell phones can be a major distraction. Students do tend to benefit more from camp if they disconnect from friends at home and focus on growing closer to God. Cell phones are allowed at Camp Tejas with restrictions and at your own personal risk. If the cell phone usage becomes inappropriate, excessive, or disruptive, the phone will be collected and returned at the end of the camp session. Please note that phones do run a high risk of being lost or damaged at camp. Also, reception at camp is not dependable. PVC will NOT be responsible for theft, loss or damage of phones.

#### **Lost Items Policy:**

If students do not return home with all their belongings, we will have a lost and found box at the West End the first weekend they return home from camp. Items will be kept for one week following camp, then will be washed and donated. It is suggested that you label all items with your child's name.

#### **Health Information:**

We have two nurses on site 24 hours a day in a well-equipped facility. We hope that your campers will never need to experience our nurse's station, but if they need us, we are here to help them! We will promptly contact you if there is an issue that affects your child's camp experience.

#### **Health Forms:**

If there are changes to your child's health condition or medications after registration has been completed, please contact our office at 956.585.3203, or email us at youth@palmvalleychurch.com to update the information.

#### **Medications:**

Campers are not permitted to keep any medications in their cabins or on their person. A nurse will be available to dispense any medications as needed. All medications (prescription and over-the-counter medications) must be brought to the Nurse's Desk at check-in, the morning of departure. Over-the-counter medications must be in their original, unopened packaging and prescription medications must be in their original prescription containers. This rule applies to all medications except for emergency medication allowed by Texas state law: an inhaler or EpiPen. However, written approval is required for any student who will be carrying an emergency medication. Written approval can be obtained from the camp nurse departure morning. Unclaimed medications will be held by student ministries staff for one week and then discarded. Please make sure to let us know about all allergies including stings, foods, and/or medicines. We can provide special dietary needs for those campers who are under medical supervision or have food allergies.

- Please Do:
  - 1. Fill out the medication form(s), if necessary.
  - 2. Bring all medications to the Nurse's Desk at check-in the morning of departure.
- Please Don't:
  - 1. Bring opened, over-the-counter, non-prescription medications.
  - 2. Bring your child to check-in if he/she has had COVID-19 symptoms within the previous 24 hours..

#### **Pricing:**

How much does it cost to go to camp?

The cost of camp is \$375 and can be paid in full at registration.

If you choose the Payment Plan option, you can secure your spot with a \$125 deposit and subsequent payments. If any payment is not made on time, you risk losing your spot at camp.

#### **Financial Policy:**

In April of 2019, Palm Valley Church updated its database to Realm. All camp registration will happen in Realm.

The cost of camp is \$375. If you choose the payment plan option, you can secure your spot with a \$125 deposit and subsequent payments. If any payment is not made on time, you risk losing your spot at camp.

#### Payment Plan Details:

- Deposit of \$125 due at registration to secure your spot
- May 16 \$125
- June 13 \$125

After May 16, the total amount required in the payment schedule is due at the time of registration.

Important Notes: If any payment is not made on time, you risk losing your spot at camp. To utilize the payment plan, you must create a Realm account if you don't already have one. You cannot access the payment plan if you register as a guest.

#### How to register for camp:

1. If you don't already have one, create a Realm account:

Fill out the "Please Tell Us About Yourself" form to finish creating your account

2. Confirm your contact information is correct and that your student(s) is linked to your account.

Click on your name and then "My Profile"

Double check that your contact information is correct, the email listed is what will be used for camp communication. On the right hand side, you will see "Family" with your student(s) name listed below.

If your student(s) is not listed under "Family", click on "Add Family" to enter their information.

- 3. On the left side of the page, click on "Events"
- 4. Type "Summer Camp 2021" in Find Events (on the right side of the page)
- 5. Click on "Register by July 27"
- 6. Choose the name(s) of your student(s) and then choose "Next"
- 7. Under "Registration", choose the registration type you prefer (One Time Payment \$375 or three payments of \$125).
- 8. Complete the registration form with parent and student information. Then choose "Next"
- 9. Enter payment information and then choose "Register and Pay"

#### How do I make a payment?

- 1. Pay in person at Palm Valley Church. Payments can be received at any kiosk on Sundays or the church office Monday through Thursday from 9:00am to 5:00pm.
- 2. Online Payment.

  - 3. Log in to your Realm account or create a Realm account if you don't already have one.

#### If I need to cancel my child's reservation, will I be refunded?

In the case of illness or positive COVID-19 test prior to departure a full refund will be given. In the case of illness or dismissal due to behavioral problems or homesickness while at camp, camp fees will not be refunded. Camp Tejas and/or PVC will not be held responsible for travel expenses incurred in picking up the child. The camp director reserves the right to dismiss any camper whose conduct becomes in any way detrimental to the best interest of the other campers. No refunds will be given. In case of illness or inclement weather, we will refund any monies that Camp Tejas refunds. Camp Tejas and/or PVC will not be responsible for travel expenses incurred in picking up the child.

#### How does the waiting list work for camp?

Each year we are forced to turn campers away due to lack of space. However, occasionally spaces do become available leading up to camp. Signing up for the waiting list does not guarantee your spot.

If a spot in your student's grade/gender becomes available, you will receive a phone call to the number provided on your camp registration form. Once we have called, you will have until 10:00a.m. the next day, to make a payment and secure your spot. Failure to do so will result in your spot being given to the next person in line on the waiting list.

You may remove your student from the waiting list and receive a full refund at any time. Refunds will be mailed in the form of a check, within 4 weeks of cancellation.

### How do I join the waiting list for camp?

The total amount required in the payment schedule is due at the time of registration to register for the waiting list.

If registering for the waiting list before May 16, pay \$125 to secure your spot on the waiting list.

If registering for the waiting list between May 17 and June 13, pay \$250 to secure your spot on the waiting list.

If registering for the waiting list after June 14, pay \$375 to secure your spot on the waiting list.

\*Signing up for the waiting list does not guarantee your spot.

#### If a spot does not become available will I be refunded?

Yes. Refunds will be mailed in the form of a check within four weeks of cancellation.

#### Camp Tejas:

#### Where does camp take place?

We take our students to Camp Tejas in Giddings, TX. For more information on Camp Tejas you can check out their website at www. mytejas.org.

### What does a day at camp look like?

Each day at camp will include: worship services, Bible study/small group discussion, high energy rec games and a chance to take advantage of all that Camp Tejas has to offer; such as zip lines, climbing walls, pools, etc.

#### **Room Arrangements:**

How are campers assigned rooms?

Campers are assigned rooms by grade and gender.

#### What is the counselor to camper ratio?

We maintain a ratio of at least 1 counselor for every 8-10 students.

#### **Supervision:**

Who is on "staff" during camp?

Camp is staffed with our PVC personnel, the Camp Tejas staff, trained leaders, and two nurses. Special precautions are taken during water activities and certified lifeguards are on duty.

#### Are campers always supervised?

Yes – counselors are present 24 hours a day.

#### How does PVC choose their counselors?

Each applicant is carefully screened and hand-picked by the Student Ministries Staff. We conduct national background checks, as well as a Child Abuse Prevention Training Course and Exam (required by Texas Law for any adult attending a camp).

#### Phone Calls, Mail, and Visitors:

## May I call my child at camp?

We do not encourage calls to students at camp. Cell phones are allowed at camp with restrictions. Please see the "What to Bring" list for full cell phone policy. Should campers need to contact parents; calls can be made through the Camp Director's cell phone.

### Can I reach someone at camp any time of the day or night in case of emergency?

Yes – The emergency number for 6th – 12th grade students is Micah Crump: 956-792-2895. Emergencies Only, please!

#### What do you do for homesick kids? Do you let them call home?

Yes – homesick campers are allowed to call home. Campers who become homesick and leave their camp session early are not eligible for refunds.

#### Can campers receive mail or packages during their stay?

No - due to the short duration of our camp stay, we do not encourage snail mail or packages to be sent to campers.

### Does Camp Tejas allow visitors?

Camp Tejas restricts access to workers and campers. All visitors need prior approval by the PVC staff and must register with the main office upon entering Camp Tejas.

#### **Medical Information:**

Is there a nurse available at all times?

Yes - Nurses are on staff 24 hours a day.

#### Which medications should my child bring to camp?

All medications (prescription and over-the-counter medications) must be brought to the Nurse's Desk at check-in the morning of departure. Over-the-counter medications must be in their original, unopened packaging and prescription medications must be in their original prescription containers. This rule applies to all medications except for emergency medication allowed by Texas state law: an inhaler or EpiPen. However, written approval is required for any student who will be carrying an emergency medication. Written approval can be obtained from the camp nurse departure morning. You can expedite this process by pre-filling the medication form(s) and bringing a printed copy with you to the Nurse's Desk on departure morning. #### Do you give kids pain reliever if needed?

Yes - the Nurse's Station has pain reliever and the nurse is available to dispense medication as needed.

### Does my child have to turn in his medicine even if he knows when to take it and how much?

Yes. All medications (prescription and over-the-counter medications) must be brought to the Nurse's Desk at check-in the morning of departure. Over-the-counter medications must be in their original, unopened packaging and prescription medications must be in their original prescription containers. This rule applies to all medications except for emergency medication allowed by Texas state law: an inhaler or EpiPen. However written approval is required for any student who will be carrying an emergency medication. Written approval can be obtained from the camp nurse departure morning. You can expedite this process by pre-filling the medication form(s) and bringing a printed copy with you to the Nurse's Desk on departure morning. All medication will be returned at the end of the camp session.

### Are feminine products available at camp?

Yes - the nurse will have a supply of feminine products.

How close is the nearest hospital?

20 minutes.

#### **Activities:**

#### What are specific activities the campers will be doing?

Campers will be involved in a variety of activities including swimming, canoeing, basketball, waterslides, inflatable games, obstacle courses, mud games, water trapeze, zip lines, lazy river, climbing wall, etc.

#### **Spending Money:**

How much money do they need to bring?

Spending money is optional. Most campers spend on average \$50 for snacks and souvenirs during their camp stay.

#### How many times are students allowed to go to the Gift Shop?

Campers are allowed to go to the gift shop during their camp session to shop for souvenirs and snacks each full day of camp.

#### Do students keep their own money at camp?

Yes - they will be responsible for their own money at camp. PVC is not responsible for lost or stolen money at camp.

According to Rule 265.15 of the Texas Administrative Code, all medications sent to camp must be surrendered to the Camp Health Officer for the duration of camp.
